

FSA DEADLINES FOR SY 2015-2016

Attn: FINANCIAL AID STUDENTS FAFSA Deadlines for SY 2015-2016

If you have not renewed or completed your FAFSA online at <u>www.fafsa.ed.gov</u> for School Year 2015-2016, please START! Include GCC Federal School Code <u>015361</u>.

Your **FAFSA** should be completed and **ALL** required documents submitted before the **PRIORITY DATES**. Refer to the **priority dates** below for the semester you plan on first attending for **School Year 2015-2016**.

MAY 7, 2015 is the financial aid priority date for SUMMER 2015 semester AND

JULY 9, 2015 is the financial aid priority date for FALL 2015 semester AND

DECEMBER 10, 2015 is the financial aid **priority date** for **SPRING 2016** semester

Do **FOLLOW-UP** with the GCC Financial Aid Office on your FAFSA application **AFTER 3-4 DAYS** from submitting your FAFSA application online.

Your FAFSA must be complete and ALL required documents submitted before the PRIORITY DATES shown above. Otherwise, YOU MAY HAVE TO RELY ON YOUR OWN RESOURCES to pay for tuition, registration fees, books, supplies and other expenses.

The GCC Financial Aid Office will be **REQUIRED** to do verifications and **REQUEST** documents on the items below. This may **DELAY** the issuance of the Deferment Letter which lets you obtain your school ID and book(s).

<u>Submit a 2015-2016 Verification Worksheet for Dependent or</u> <u>Independent Students</u> (download at www.guamcc.edu—Financial Aid)

For all applicants:

Household size Number in college Child support paid in 2014 SNAP benefits (formerly food stamps) – **Submit certification from Public Health & Social Services for 2013 and 2014**

For non-tax filers—Submit: Income earned from work or W-2(s) for 2014

For tax filers (student and if married, spouse)—Submit 2014 <u>Tax Returns 1040EZ/1040A/1040/Amended returns and W-2(s):</u> Adjusted gross income (AGI) U.S. Income tax paid Education credits Untaxed portions of IRA distributions Untaxed portions of pensions IRA deductions and payments Tax-exempt interest income
