

<u>GCC-RFQ-15-006:</u> Turnkey: Acoustical Treatment of Noisy Stairways within the GCC's Learning Resources Center, Building 4000

The Guam Community College (GCC) is soliciting the services of qualified Contractors to assess & retrofit the front, west-side stairway within its Learning Resources Center, Building 4000; toward substantially reducing the noise to <u>below</u> its current decibel levels; and including (but not limited to) the following ...

Background:

The GCC has observed high-decibel, distracting noises coming from its front, west-side stairway of its Learning Resources Center, Building 4000; and most especially during high-occupancy periods.

This Building 4000 stairway was newly-constructed over 3-years back, and with the latest acoustical treatment; however & be it from normal wear-and-tear &/ defective materials, the GCC has deemed it timely to revisit & resolve the noise distraction.

Accordingly, it is the GCC's intention to source SMEs in the acoustical treatment of stairways & noise reductions.

General Requirements & Scopes of Work:

- 1. Participants shall provide their lump-sum, firm-fixed-price for the assessment, retrofit & treatment of the GCC's Learning Resources Center's stairways ...
 - a. consisting of 22-steps each at approx. 4.5' wide,
 - b. toward eliminating / substantially-reducing the current noise levels,
 - c. with aesthetic~conformance to the existing construct~color~texture~etc. schemes,
 - d. of similar / better treatment to those outlined within the attached links ...

- 2. Participants' quote shall be for SOW nos. 1.a. through 1.d.iii + 3. through 10. \$
- 3. Participants shall provide a rendering / shop drawing of their planned build with their quoted pricing;
- 4. Participants shall complete this Project within 30-calendar days upon receipt of Purchase Order;
- 5. Participants shall provide a 1-year, Certificate of Warranty for all parts & workmanship, and commencing immediately upon the GCC's explicit acceptance of the project;
- 6. Participants are to properly dispose of all waste & debris associated with the project;
- 7. Participants shall conduct a holistic assessment of this project, and ...
 - a. shall provide a submission that includes all of the component elements for complete, compliant operation,
 - *b. shall indemnify the GCC for any under-estimations / oversights attributed to their lack of due diligence or wrongful assumptions;*
- 8. Participants shall provide P&S, shop drawings, technical documentation, brochures, etc. as is necessary for the GCC to thoroughly review & explicitly approve;
- 9. Participants shall obtain the requisite permits, clearance, approvals, etc. from Agencies having jurisdiction (if required); and
- 10. Participants shall take all precautions to assure that the GCC's population remain out of harm's way throughout this project.
