Minutes

I. CALL TO ORDER

The monthly meeting of the GCC Board of Trustees held on November 16, 2017, was called to order at 12:05 p.m., by Chairperson Frank Arriola, in the President's Conference Room located at the Student Services & Administration Building in Mangilao, Guam.

1. Roll Call. <u>Trustees Present</u>: Mr. Frank P. Arriola, Chairperson; Mr. Richard P. Sablan, Vice Chairperson; Mr. Eloy P. Hara, Treasurer; Ms. Deborah C. Belanger; Mr. Luke Fernandez, Student Trustee. **Other members**: Ms. Gina Ramos, Secretary (schedule conflict); Mr. John Benito (off-island).

Others in attendance: Dr. Mary A.Y. Okada, President; Mr. Frederick Tupaz, Faculty Advisory Member represented by Mr. Carl Torres; Mr. Kenneth Bautista, Support Staff Advisory Member; Dr. R. Ray D. Somera, Vice President, Academic Affairs Division; Ms. Carmen K. Santos, Vice President, Finance & Administration Division; Dr. Gina Tudela, Dean, TPS; Mr. R. - 2. Recital of Mission Statement. Board members recited the Mission Statement: Guam Community College is a leader in career and technical workforce development, providing the highest quality, student-centered education and job training for Micronesia.
- II. APPROVAL OF MINUTES October 19, 2017

MOTION

IT WAS MOVED BY TRUSTEE RICHARD SABLAN, AND SECONDED BY TRUSTEE ELOY HARA, THAT THE BOARD APPROVE THE MEETING MINUTES OF OCTOBER 19, 2017, WITH CORRECTIONS. NONE OPPOSED, MOTION CARRIED. (Voting: 5 ayes, 0 nays)

- IV. PUBLIC DISCUSSION No request.
- V. REPORTS
- 1. **President's Report:** President Okada reported on the following: **Financial Status:** The President provided the Board with a current financial status of the College as follows:

FY2018: The College has received \$2.16 million year to date from the General Fund for regular operations, LPN and for the general fund component for the apprenticeship program. This equates to 62% of the requested amount based on the allotment schedule.

FY2017: There is no additional funding received yet for the College for FY2017 but will continue to track this with DOA.

Capital Improvement Projects and other activities: President Okada reported the following:

- -Barricades have been set up for the walkway leading towards Building 500. This project is ongoing and access for this ramp is unavailable.
- -Waiting for the bid evaluations for Phase 2 of the campus painting project for the Technology Center and Building 2000 (administration building). Four bidders submitted bids on October 30, 2017.
- -A/C bids for repair are currently under evaluation and awaiting recommendations.
- -Anticipate getting signage up especially directional signs before the Accreditation visit in March 2018.
- -Working on replacing the dilapidated perimeter fence in front of the campus around the ponding basin, which has already been awarded. Replacing it right now until a permanent structure is built and communicating with the contractor to ensure this project is completed on time.
- -The GCC maintenance staff will continue to assist with the water blasting around campus as part of the painting project, which will be done in phases.
- -Working on fire suppression systems that was last replaced with ARRA funding in four facilities that now has to be replaced due to deterioration.
- -The President also reported that although the Board approved the budget for the CIP projects, the Resource, Planning & Facilities Committee approved a list of projects and she will be reporting out on a monthly basis as they progress.

Other activities:

Accreditation Updates (with Data Extract): The President reported Data Extract #4 as follows:

This extract, "Community College Survey of Student Engagement" was the basis for the October 23, 2017 College Assembly.

- -Results of the survey were discussed with faculty, staff and administrators.
- -Feedback was gathered as to how to address some of the particular issues.

As an example, one of the questions on the survey was "how many hours do students spend in a typical 7-day week preparing for class."

- -For GCC, there were 542 respondents and based on these results, students spent approximately 50% of their 7-day week only contributing 1-5 hours studying, reading, writing, rehearsing, doing homework.
- -Further results for GCC were 30% contributed 6-10 hrs.; 11.9% contributed 11-20 hrs.; 4.2% contributed 21-30 hrs.; and 3.1% for more than 30 hours.
- -This information extracted is compared to small colleges of similar size and is based on the total cohort done by the Center for Community College Student Engagement, which is a national organization that compiles this information.
- -These are the areas that GCC is currently looking at and in comparing 1-5 hours, GCC is at 49.6%, the cohort at 39.5%, and small colleges at 39%.
- -On the shaded area GCC is 19.3%; small colleges at 32.3% and the cohort at 28.7%.

Another question on the survey was the "coming to class without completing readings or assignments."

- -Students' responses for GCC were never at 22.8%; sometimes at 58.5% (approximately over ½); often at 15%; and very often at 3.7%.
- -GCC is looking at the 22.8% and to try and identify some strategies to support these findings.
- -The shaded area has small colleges at 36.4% and the cohort at 34.1%.

The last question is "received prompt feedback (written or oral) from instructors on your performance."

- -Some students indicated never received prompt feedback at 9.1%; sometimes at 37.5%; often at 35.7%; and very often at 17.7%.
- -Shaded area is 46.6% for GCC and is the area GCC will try to address; small colleges at 37.5% and the cohort at 39.2%.

The President again explained these are student surveys that are done and have been extracted to identify areas of improvement as part of the College's transformation process.

- -The information shared with the Board will also be provided during the accreditation visit.
- -This is one of the ways the College uses data for continuous quality improvement for selfevaluations and utilizing data to make decisions.
- -Based on strategies discussed during the College Assembly by staff, faculty and administrators, these will be extracted and results will be shared at the next College Assembly.

At this time, the President informed the Board that there is an articulation agreement with UH Manoa and waiting to receive the official document for this. This is a project that Dr. Ray and PPEC have been working on for three (3) years. The tuition component is with the WICHE program, which a student would have to apply for. Hawaii is a WICHE state.

-A lot of information is being requested regarding a middle/free college concept and in discussions with McREL in Honolulu, research on this is ongoing.

2. Monthly Activities Report.

Student Trustee: Trustee Luke Fernandez reported the following:

- -November 17, 2017, 12pm, is the last COPSA General Membership meeting.
- -December 13, 2017, 9:00 a.m., New Student Orientation for Spring 2018.
- -GCC 40th Anniversary Gala was held on November 10, 2017 and on behalf of the COPSA Officers, Trustee Fernandez thanked GCC for the invite and said they enjoyed the event.

<u>Faculty Advisory Member</u>: Mr. Fred Tupaz was represented by Mr. Carl Torres and reported the following:

- -October 17-18, 2017: Faculty had an "ON AIR" On Art in Research presentation, which is part of the English Department's convocation, who combined efforts with Automotive Department this year, and reported this was a success. Efforts were also from the students and the community. Included was a workshop by Dr. Laura Souder on publishing and writing and a poetry workshop by Kie Susuico.
- -November 12, 2017: The GCC/First Hawaiian Bank John K. Lee Jr. 2K/5K Run/Walk was held

at the Chamorro Village. There was a net amount of \$7,400 raised and deposited into the JKLee Scholarship Fund.

-Nov. 17-18, 2017: The 1st annual Marianas Terrestrial Conservation Conference will be held at GCC in the MPA. There will be 83 participants and approximately 7 classes will be attending.

Support Staff Advisory Member: Mr. Kenneth Bautista reported the following:

- -Staff attended the College Assembly, Oct. 23, 2017, and data extract was also explained, and received further information regarding Title IX, including what to do in certain situations and a mandatory online training regarding sexual harassment.
- -Attended the GCC 40th Anniversary Gala event on Nov. 10, 2017.

3. Board of Trustees Community Outreach Report.

- -"ON AIR" October 2017 for the English Department attended by Trustee Fernandez.
- -College Assembly on Monday, Oct. 23, 2017, 8am-4pm, in the GCC MPA was attended by Trustees Belanger and Luke Fernandez.
- -Trustee Belanger has also been attending ongoing Standard IV and the Accreditation Steering Committee (ASC) team meetings at the College.
- -November 3, 2017, COPSA General Membership meeting attended by Trustee Fernandez.
- -November 8, 2017, 12:00 Noon in the GCC MPA, GCC Culinary 4 course sit-down luncheon, were attended by Trustees Hara, Belanger and Fernandez. This included a meet and greet with the Accreditation Team from the American Culinary Federation Education Foundation with Chefs Jeremy Abbey, John Piazza and Steve Mannion.
- -GCC 40th Anniversary Gala on Friday, November 10, 2017, 6pm-10pm, at the Dusit Thani was attended by Trustees Arriola, Hara, Sablan, and Fernandez. Trustee Sablan is a member of the band that was part of the music entertainment.
- -November 2017, Trustee Fernandez participated with VisCom students in the set-up of trains and holiday decorating at the Guam Hilton.

VI. UNFINISHED BUSINESS

1. Construction Projects Updates. President Okada reported on the following:

- <u>-Bldg. 100.</u> This project is progressing and as of October 31, 2017, is 52% complete. Awaiting a change order, which is currently being evaluated by the architect due to relocation of Cosmetology and upgrade of old electrical lines.
- <u>-Forensic Lab.</u> This project is on a procurement stay pending the results of the protest already on file with OPA.
- -Building 300. This project is currently under evaluation with the architect and three bids were submitted on November 1, 2017.
- <u>-Wellness Center</u>. As previously reported during the last meeting, the College is waiting for P3 discussions with USDA. The President will also follow up for a timeline with USDA.
