



Consortium Agreement Form between University of Guam and Guam Community College

The University of Guam (UOG) and the Guam Community College (GCC) will accept the transfer of credits as listed under the Course Articulation Matrix as equivalent or comparable as per the current UOG and GCC Undergraduate Catalogs at the time of admission.

Student Criteria

The student is expected:

- 1. To take courses that are transferable to their declared program of study.
- 2. To be declared/admitted in the program of study at their Home School.
- 3. To maintain satisfactory academic progress as specified by their institution's policy.
- 4. To submit transcripts from the Host School to their Home School at the end of the semester.
- 5. To ensure they are **NOT** receiving financial aid at the Host School. *Federal Regulations only allow a student to receive federal student aid from one institution at a time.
- 6. To notify the Home School's Financial Aid Office if he or she withdrawals from any classes taken under this agreement.
- 7. To ensure payment is made to the Host School.
- 8. To submit this completed form along with a copy of their registration from the Host School to the Home School's Financial Aid Office. In addition, a copy of the form will need to be submitted to the Host School's Registrar's Office.
