- 1. Roll Call. Trustees Present: Mr. Frank P. Arriola, Chairperson; Mr. Carlo Leon Guerrero, Vice Chairperson; Mr. Eloy P. Hara; and Mr. Kenly Magwili, Student Trustee. Ms. Rose P. Grino, Secretary (off-island); Richard P. Sablan, Treasurer (schedule conflict).

- 1. President's Report: President Okada reported on the following:

<u>Financial Status</u>: The President provided the Board with a current financial status of the College as follows:

FY2022: As of to date and based on appropriations, the College received a total of approximately \$13,945,934.00. This equates to 92% of the total amount based on the allotment

schedule and 69% of the total appropriations for the fiscal year, as follows: \$10.6 million for the General Fund; approximately \$2.9 million for MDF; \$52,000.00 for the POST Commission; \$200,400.00 for the Capital Improvement Fund; and approximately \$146,000.00 for the First-Generation Trust Fund Initiative.

<u>Capital Improvement Projects and other activities:</u> The following is a report from the President.

Other activities:

The College continues to offer boot camps with several ongoing such as the soon to complete Childcare and the Truck Driving boot camps. Other boot camps will be offered during the upcoming months. There will be a second cohort for the Intro to Criminal Justice course which is open to any 2022 graduate.

May Activities:

The College participated in EMS week, which recognizes the College's role in serving as educators for the island's EMS teams.

The College had a successful academic year 2022 graduation with 240 of the 296 graduates attending the graduation face-to-face on May 13, 2022, at the UOG Calvo Field House with families and friends. The Most Distinguished and Distinguished Graduate ceremony was held on May 11, 2022, and the Practical Nursing pinning ceremony for 13 graduate candidates was held on May 10, 2022.

The College will be recognizing the Certificate of Mastery and Certificate of Completion for secondary students; the literacy navigator project will be launched this summer; additional tutoring services will be provided to summer school students; the College offered additional Math and English courses utilizing CARES funding to support students entering postsecondary education; the ServeSafe team has been expanded with additional faculty and the program is taught in Korean with the passing rate of 81%; summer enrollment increased with this year's total enrollment of 287 compared to 240 enrolled last year.

Funding is being applied for a mural project for the barrel vault; HR is working on a mental health first aid training for GCC employees and additional training for all EEOs on campus.

With GCC celebrating its 45th anniversary and UOG celebrating its 70th anniversary, the two institutions are collaborating in building a float for this year's Guam Liberation Day parade. The College has also applied for gold sponsorship with Guam PBS for footage coverage during the parade.

2. Monthly Activities Report.

<u>Student Trustee:</u> Trustee Kenly Magwili reported the following: Students enjoyed the traditional face-to-face GCC graduation and having their families and

friends attend.

The newly elected COPSA officers along with the Student Trustee are attending training sessions this summer and will be preparing for the upcoming academic year.

6/3/2022: The Student Trustee along with other student leaders attended a training by WestCare Pacific regarding providing prevention services for substance and alcohol abuse.

Summer classes began last week Friday, June 3, 2022 and so far it is going well.

Faculty Advisory Member: Ms. Simone Bollinger was not in attendance for today's meeting.

<u>Support Staff Advisory Member</u>: Mr. Kenneth Bautista reported the following: Staff are preparing for the summer classes.

Staff and other GCC employees attended the May 13, 2022 GCC graduation ceremony.

Board of Trustees Community Outreach Report:

Trustee Leon Guerrero reported that he and Trustee Grino attended the GCC graduation ceremony on behalf of the Board on May 13, 2022. Trustee Leon Guerrero further reported that the graduation was held indoors and was successful given the short timeframe for the College to prepare it face-to-face and that it was also well managed.

President Okada reported that Trustee Leon Guerrero attended the ACCT Pacific Regional meeting via Zoom on May 10, 2022, with representatives from CNMI and as an invite by the NMC's Chairman. This meeting was to discuss initiatives and areas of needed support with the leadership team at ACCT.

VI. UNFINISHED BUSINESS

1. Construction Projects Updates. President Okada reported on the following:

<u>Forensic Lab/DNA Building.</u> This project is 99.17% complete to date and currently working on the air flushing required for the LEED Certification; continue the DDC work and the installation of the fire alarm devices to finish testing; there are delays with some of the electrical devices; and waiting on the substantial completion in order to pass the GFD inspection. Anticipate completion with this project by August 2022.

<u>Building 300.</u> This project completion rate has been recalculated at 94.17%. The completion date had to be reassessed and the fire sprinkler and fire alarm system would have to be done in order to obtain substantial completion.

<u>Wellness Center.</u> The first application for funding for this project has already been submitted and the College anticipates an update in a couple of months. The College is currently working on the second funding.

Building B. Waiting on building permits and anticipating the groundbreaking towards the end

Workforce Development Center (Barrigada property). As last reported, the U.S. Economic Development Authority (EDA) requested an appraisal on this property, which is currently appraised at \$1.5 million. Anticipate EDA to provide an update with the submission of this appraisal.
