1. President's Report:

Financial Status of the College:

President Okada reported that as of December 31, 2007, GCC collected about \$2.3 million of its FY08 appropriation with a balance of \$2.687 million still due. Because GCC is still loading its FY08 budget into its new financial system, in the next months the Board will see an increase in expenditures by the College. With regard to the repayment of the loan to USDOE, USDOE confirmed receipt of GCC's first interest payment. For the payment due by June 1, 2008, monies for that payment has been set aside and placed in a TCD.

VI. UNFINISHED BUSINESS

1. New Science & Allied Health Building (Update)

President Okada reported that per Shawn Gumataotao from the Governor's office, USDOI's budget is still pending the approval by U.S. President Bush. She reiterated that of the \$10 million that is being requested by Guam, \$3 million of that amount will be given to GCC for its Science & Allied Health Building.

2. Board Assessment

President Okada reminded board members that they will be provided, for their input, a copy of the Board's Self Evaluation Questionnaire (BSEQ) and a copy of the Governing Board's Assessment Questionnaire (GBAQ) before the scheduled Joint Boards Retreat. Completed surveys are to be submitted to Lou Bautista at the Retreat on January 19th, or anytime before February 7, 2008.

3. Proposed Board Policy: GCC Ethics Policy (2nd Reading)

President Okada reiterated that at the Board's last meeting the proposed policy was moved into second reading for continued review and dialogue. Referring to the second and last paragraphs under the Introductory Statement on page 2, Chair Ramos recommended that because the second paragraph indicates that as representatives of GCC we also interact and develop close ties with representatives of governmental agencies and the private sector, that the last paragraph also include external stakeholders if they are representing the college. For clarification, Dean Santos said that as long as it is clear that "external stakeholders" are in the capacity of representing GCC.

In light of the discussion and suggestion to amend the last paragraph on page 2, legal counsel, for the next meeting, was asked to review and provide feedback on the issue of at what point does the proposed policy move into the next reading.

NOW, THEREFORE, BE IT RESOLVED, that the Mission Statement be scheduled for reexamination in due course by the College community in January of each year; and

NOW, BE IT FURTHER RESOLVED by this resolution, that the following Mission Statement represents the institutional reexamination and adoption of the following Mission Statement for January 2008:
