GEAR Workshop, held last October 23, 2020, was well-attended by stakeholders from the K-12 to postsecondary institutions, the Guam Legislature, the Office of the Governor of Guam, the Office of the Attorney General, the Guam Federation of Teachers, the Guam Education Board, the REL Pacific, and the PREL.

The evaluation of the workshop was conducted by the University of Guam. Highlights of the evaluation included: (a) over 50% of the workshop attendees participated in the evaluation survey (b) 97% either agreed or strongly agreed to the statement "My knowledge level was increased or enhanced as a result of attending the workshop:", (c) 91% indicated that they strongly agree that "The research topic was relevant for the Guam Education Research Agenda", (d) 71% indicated that they strongly agree that "The session discussion was productive, well-organized, and worth their time as stakeholders".
